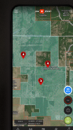

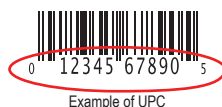

WHO QUALIFIES & WHO DOES NOT QUALIFY

- Rebates are valid only to end use consumers in all US states, District of Columbia, Puerto Rico and U.S. Virgin Islands & all Canadian provinces (paid in U.S. funds only). - Original UPC barcode(s) from product packaging. Case barcodes are accepted if product purchased in case qty.
- Product package image of FRONT OF BOX & SIDE OF BOX are required in online submission form.
